



## Documentation Required With Licence Application

**It is the responsibility of the applicant to provide all of the required information**

**Applications will be reviewed only when ALL of the required documentation is received.**

### 1. All applications:

- Completed ASN licence application form.
- Copy of current membership card in a club, which is affiliated to ASN Canada FIA.
- A completed ASN Medical form as follows:
  - **All first time Licence applicants must submit a medical**
  - **International Licence applicants** must have a medical every year
    - i. a Stress ECG is required every two years if applicant is 45 or older
  - **National Licence applicants must have a medical:**
    - i. every 5 years between ages 9 & 35
    - ii. every 2 years between ages 36 & 59
    - iii. every year over 60 years of age
    - iv. Medical History **Self-Declaration** Form to be completed and submitted on the years when a Physical Examination is not required (see above)

**NOTE: Applicants should keep a copy of their completed medical form**

- Copy of most recent or current competition licence.
- Proof of recent competition experience (e.g. **Copy** of drivers log card, event results or series results).
- Appropriate fee, made payable to ASN Canada FIA by cheque, e-transfer, bank draft or money order.

### 2. International Licence applicants must also attach the following:

- A high resolution head shot photo in JPEG format, 2 inches wide (50 mm), to be emailed to admin@asncanada.com
- NOTE: Drivers and Entrants who enter in an International Competition outside of Canada, that is listed on the FIA International Sporting Calendar can only do so with a letter of Permission of ASN Canada FIA. Please contact the office if you have any questions regarding Letters of Permissions/Visas.

### 3. New Race applicants must also attach the following:

- Copy of racing school certificate with Chief Instructor's endorsement (Schools are only those professional and club racing driver schools recognized by ASN Canada FIA. - Contact this office for further details)
- Proof of age (e.g. **Copy** of a Birth Certificate, Drivers Licence, Age of Majority Card or Passport)

### 4. New Kart applicants must also attach the following:

- Proof of age (e.g. **Copy** of a Birth Certificate, Drivers Licence, Age of Majority Card or Passport)

### 5. Upgrade applications in the same year must also attach the following:

- Current race competition licence (not a copy)

**NOTE: ASN Canada FIA must receive your current licence before the upgrade licence can be issued.**  
If your application for an upgrade is not approved your current licence will be returned to you.

### 6. Applicants under the legal age of majority in the Province of residence must also attach the following:

- Signed "Annual Parental Consent" (a copy of this document should be kept by the applicant and kept with the applicants licence to show, when requested, at registration for an event)

### SECTION 3 - Licence(s) Applied For

- Licences are valid from date of issue to the end of the calendar year.
- Allow 15 working days for receipt of licence by regular post. If application is received less than 15 days prior to event, an additional fee of \$75.00 will be charged.
- If you require your licence returned by Courier include the fee below with your application.
- Competitors **upgrading** a **current Regional Race Licence or CARS National Rally Licence** to an ASN Canada FIA National or International licence, **prior to July 1<sup>st</sup>, will be charged the full licence fee.** If the application is made after July 1<sup>st</sup> the upgrade fee of \$125.00 will apply.
- If you are applying for an upgrade to a **current ASN Canada FIA Race Licence**, the upgrade fee of \$125.00 will apply at any time.
